I understand that in the interest of public safety and security, and as provided for in the Wayne County Airport Authority Airport Ordinance, Sections 11.6(a), the denial, suspension or revocation of my ID Badge or other credential issuance may occur if I (1) have been (a) arraigned on or charged with (without final disposition), or (b) found guilty, plead guilty, plead no contest to, had adjudication withheld, or been found not guilty by reason of insanity of one of the TSA disqualifying crimes (identified in 49 CFR 1542.209), (2) am currently on parole, probation, or am required to wear, by court order, a "tether" device, or (3) have an outstanding warrant .

I also understand that the Airport Authority's Chief Executive Officer, or his or her designee, may deny issuance of a DTW ID Badge if, in their reasonable judgment, such issuance threatens the safety and security of the public and or the Airport. This may include a denial for a **non-TSA** disqualifying crime if the offense occurred on Airport property and the offense interfered with or threatened the property, safety, comfort, or security of passengers, employees, tenants or Airport operations. A person denied a DTW issued ID Badge under this provision shall have the right to appeal with a formal request to the Chief Executive Officer.
