Istakur Rahman reported that six proposals were received; two were considered nonresponsive, and four were evaluated in response to the competitive solicitation for the Airport Authority's External Auditor for Fiscal Years ending September 30, 2015 and 2016. The Evaluation Committee is recommending to the Audit Committee the respondents providing the three proposals with the highest points. In accordance with Public Act 90, the Audit Committee's recommendation is forwarded to the Wayne County Commission and the Commission has 30 days to select one of the three firms. If the Wayne County Commission does not act within 30 days, the Airport Authority then appoints the External Auditor. The Audit Committee recommends Plante & Moran, LLC.
