## **Detroit Airport CPA Lauren Foster Tapped to Join First National Leadership Academy for Young CPAs**

DETROIT—Lauren Foster, Assistant Controller with Wayne County Airport Authority (WCAA), is one of 28 Certified Public Accountants (CPAs) under age 35 from around the United States selected by the American Institute of Certified Public Accountants (AICPA) for its first annual Leadership Academy.

In addition, the candidates each had to supply a statement explaining why participating in the Leadership Academy would be important personally. The AICPA reviewed and evaluated each submission.

"The Airport Authority applauds AICPA for their selection of a highly qualified and talented professional who has already proven to be a strong and capable leader within our organization," WCAA CEO Lester Robinson said of Foster. "As a CPA myself, I am excited to see such an investment in our next generation and am proud to have one of our very best contributing to and learning from such a selective program."
