Detroit Metropolitan and Willow Run airports invite community to discuss Master Plan updates

DETROIT (April 25, 2016) – Detroit Metropolitan (DTW) and Willow Run (YIP) airports are seeking the community's input on their Master Plans. The public's involvement is critical to this process, since Master Plans reflect the long-term goals of airports to accommodate passenger, cargo and general aviation activity over the next 20 years.

"Based on a recent assessment, we're confident Detroit Metropolitan Airport is positioned to accommodate future activity and growth," said Airport Authority CEO Thomas Naughton. "Despite the expected growth in total passengers, our forecast indicates an additional runway at Detroit Metropolitan Airport is not anticipated to be needed within the next two decades. This is a key example of the important information we look at during the Master Plan update process. We also want to make sure our DTW and Willow Run neighbors and customers have the opportunity to understand our planning process, share their ideas and remain engaged with our team."

Willow Run, which is a primary reliever airport for DTW, serves general aviation, cargo and corporate jet markets. Like Detroit Metropolitan Airport, there are opportunities and challenges to consider at YIP. This week, the Airport Authority will examine these issues during the first Public Information Meetings of the current Master Plan update process.

Willow Run Airport (YIP) is an important corporate, cargo and general aviation airport located in Michigan's Ypsilanti Township. Occupying 2,600 acres, the airport has excellent services and infrastructure for airports in its class: three runways, including an all-weather instrument landing system (ILS) runway; 24-hour aircraft rescue firefighting facilities; on-site weather bureau service; 24-hour FAA control tower and US Customs service; newly upgraded runways and taxiways; snow removal; flight instruction, cargo and hangar facilities. Willow Run is also home to the FAA's Flight Standards District Office, an important resource for pilots/ flight crews, and the Yankee Air Museum which hosts the annual Thunder Over Michigan Air Show and retells YIP's storied history, from its origins as one of Henry Ford's assembly plants, which produced more than 8,700 B-24 Liberator Bombers during WWII.
